Sand Point Commercial Salmon Fishery Advisory Announcement #18 **For Emergency Order #4-FS-M-SP-14-22**

Commercial salmon fishing by **set gillnet and seine gear** will be extended for 48 hours from 6:00 p.m. Monday, July 25 until 6:00 p.m. Wednesday, July 27 in Orzinski Bay, those waters northwest of a line from Elephant Point at 55° 41.92' N. lat., 160° 03.20' W. long. to Waterfall Point at 55° 43.18' N. lat., 160° 01.13' W. long.

Commercial salmon fishing by **set gillnet and seine gear** will be allowed for 36 hours from 6:00 a.m. Tuesday, July 26 until 6:00 p.m. Wednesday, July 27 in the following districts and sections:

Unimak District
Southwestern District
South Central District
Shumagin Islands Section of the Southeastern District

Commercial salmon fishing by **drift gillnet gear** will be allowed for 36 hours from 6:00 a.m. Tuesday, July 26 until 6:00 p.m. Wednesday, July 27 in the following districts and sections:

Unimak District
Ikatan Bay Section of the Southwestern District

All closed waters in the above locations will be as described in the regulation book or as adjusted by emergency order.
